The group will be facilitated by long term members of the Mentoring Group and individuals who have education and experience in working with challenging behaviors and providing positive behavioral supports.

Members of the group present difficult cases from their organization and receive feedback from the group. Members also provide presentations to the group on areas of interest and/or expertise. The group additionally brings in guest presenters who have expertise in areas that the group has expressed an interest in. The goal of the group has been to provide a venue for staff that would like to expand their skill level in providing positive behavioral supports for people with special needs and to also provide those staff with a peer group to assist them with difficult cases.
